<u>Read this agreement carefully before signing.</u> By signing this agreement you are giving up certain rights, including the right to recover damages in case of injury, death, or property damage.

In consideration of being allowed to participate or volunteer for Laramie Jubilee Days, Inc., a Wyoming non-profit corporation ("LJD"), or otherwise participate in events or activities related to Laramie Jubilee Days® (collectively referred to as the "Event"), I hereby assume all responsibility for any and all risk of loss, damage, or injury that I or my property may sustain while participating in any activity related to the Event of any nature and any other activities sponsored by LJD, including the use of equipment, interaction with livestock, and performance of any manual or physical labor. I acknowledge that volunteering and otherwise participating in the Event involves certain dangers, including, but not necessarily limited to those associated with automobile and pedestrian traffic, livestock, weather, and crowds of people, the risks of which I assume, whether foreseen or unforeseen, and which can include serious bodily injury or death. I understand that LJD makes no warranty or guarantee as to the suitability or safety of any equipment, tools, or other property that it may provide me or which I use while volunteering, participating, and otherwise engaging in the Event.

I hereby release LJD and all its officers, directors, and agents from any and all liability for any and all causes of action which I may hereafter have on account of any and all injuries to me or my property, including death, arising out of or related in any way to the Event or my participation in the Event, whether such injury results from the negligence of LJD or any of its officers, directors, agents, contractors, participants, or volunteers, or from any other cause. I promise not to sue LJD or any of its officers, directors, and agents and agree to indemnify and hold harmless each of them from any liability asserted by any person or entity on account of any injury to me and my property, including death, and I further waive any and all claims, demands, actions or causes of actions against them or each of them arising out of or related in any way to the Event or my participation in the Event, including but not limited to a claim for wages, claim for liability, or any other claim deriving from my participation as a volunteer, participant, or in any other capacity, whether said claim, demand, or cause of action arises from the negligence of LJD or any of its officers, directors, agents, contractors, participants, or volunteers, or from any other cause. I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the State of Wyoming, and that if any portion thereof is held invalid, it is agreed that the remaining provisions shall, notwithstanding, continue in full legal force and effect. These provisions are also binding upon my heirs, executors, administrators, personal representatives, successors and assigns and shall inure to the benefit of LJD and all its officers, directors, and agents, and their heirs, executors, administrators, personal representatives, assigns and successors in office.

COVID-19 NOTICE, RELEASE, AND WAIVER. I further understand and agree as follows: The novel coronavirus ("COVID-19") is a disease that includes several symptoms according to the Centers for Disease Control ("CDC"), such as fever or chills, cough, shortness of breath, nausea, and can lead to death. COVID-19 is contagious and means that contact with others, even those who are asymptomatic can lead to infection. The circumstances regarding COVID-19 are changing from day to day and that, accordingly, state and federal orders and guidance are regularly modified and updated. Participation in any activities associated or related to LJD may inevitably lead to the exposure of COVID-19, of which LJD has no responsibility whatsoever.

I understand and agree that it is impossible for LJD (or anyone) to prevent all risk of infection; LJD has no responsibility whatsoever to take any action or be responsible for any COVID19 related issue or illness, of which I am fully responsible for the same.

By signing this agreement, I acknowledge the contagious nature of COVID-19, the fact that it can be difficult to identify in another, and the inherent risk of exposure. I acknowledge the risk that I may be exposed to or infected by COVID-19 by my presence on the property or participation in any activities related to the Event, and that such exposure or infection may result in personal injury, illness, permanent disability, and/or death.

I understand and acknowledge that given the unknown nature and variations of COVID-19, it is not possible to fully list each and every individual risk of contracting COVID-19. I understand that the risk of becoming exposed to or infected by COVID-19 while engaging in activities associated with the Event may result from the actions, omission, or negligence of myself.

I do hereby knowingly and intentionally waive, release and discharge LJD and all its officers, directors, agents, insurers, representatives, or affiliates from any and all claims, causes of action, liabilities, suits, expenses or damages of any kind or nature whether direct or derivative which are related to, arise out of, or are in any way connected with LJD and the Event due to attendance, entry, participation or activities related to LJD, including human error or negligence of any kind or nature. I further agree to indemnify and hold harmless LJD and the other persons or entity from any claim by me or my family, estate, heirs, personal representatives, successors or assigns. I understand that my agreement to indemnify and hold harmless LJD includes all expenses and costs, including attorney's fees. I further waive, release and discharge LJD and the other persons and entities from any claims I may have in the future which arise from any injury, illness (including but not limited to COVID-19), paralysis or death to me, my child or children or agents. I understand that my agreement to indemnify and hold harmless LJD includes all expenses and costs, including attorney's fees.

I understand that this Agreement remains in effect so long as I participate and/or attend any activities associated with LJD and the Event.

By signing this document, I confirm that I have carefully read the foregoing release, that I understand the contents thereof, and agree to the terms of this release as my own, free and voluntary act. I UNDERSTAND THAT BY SIGNING THIS DOCUMENT I MAKE CERTAIN PROMISES AND WAIVE CERTAIN RIGHTS, INCLUDING THE RIGHT TO SUE ON BEHALF OF MYSELF AND MY CHILD.

I further agree that photographs, pictures, or videos may be taken of me in connection with my participation in the Event without compensation from anyone, and I consent to the use of these photographs, pictures, or videos for any legal purpose.
